I therefore voluntarily accept and expressly assume all risks, dangers, and hazards that may arise from my use and any other person's negligent use of firearms and ammunition while I am on or in a JC-SC firearm facility or range, including death, injury, or illness suffered by my person or damage to my property.

I further covenant and agree to hold harmless and indemnify JC-SC, its successors its officers, board members, members at-large, its agents, and insurers for and against any claims, demands, suits, damages, expenses, costs, attorneys fees, or other fees incurred by JC-SC, its officers, board members, members at-large, its agents, and insurers, as a result of my use of the premises and firearm facilities of JC-SC, including any negligent acts or omissions by JC-SC, any member, visitor, or guest of any JC-SC member while I am using the firearm facilities and ranges of JC-SC.
